Project teams must focus on preventing problems by planning for contracts, tendering, contract administration and dispute management. This presentation and discussion will include management practices, legal principles and case law., and alternatives for dispute resolution

ETHICS COST! Joan Vincent - This presentation explores the relationship of ethics to cost and risk in a project management environment.

SHOW US YOUR ETHICS: DEALING WITH DILEMMAS WHILE MANAGING PROJECTS. Walter Wawruck, PMP.
